Lexington School District One requires proof of residency for each student. Proof of residency is to be verified by the most current electric statement or lease/rental agreement. The statement or agreement must be listed in the parent's/legal guardian/s name. The parent/legal guardian must also present a valid picture ID that shows the legal residence of the parent/legal guardian. The parent and student must reside at the address presented. P.O. Box addresses are not accepted. **This policy does NOT apply to Seniors.** Seniors do not have to produce proof of residency but will need to verify that the school has their correct address on file.
